INTENSIVE CARE ADD-ON (All Tiers)

For patients needing more frequent support, add a second monthly visit:

- Tier 1: +\$200/month (total \$400/month)
- Tier 2: +\$150/month (total \$300/month)
- Tier 3: +\$100/month (total \$200/month)
- Tier 4: +\$50/month (total \$100/month)
